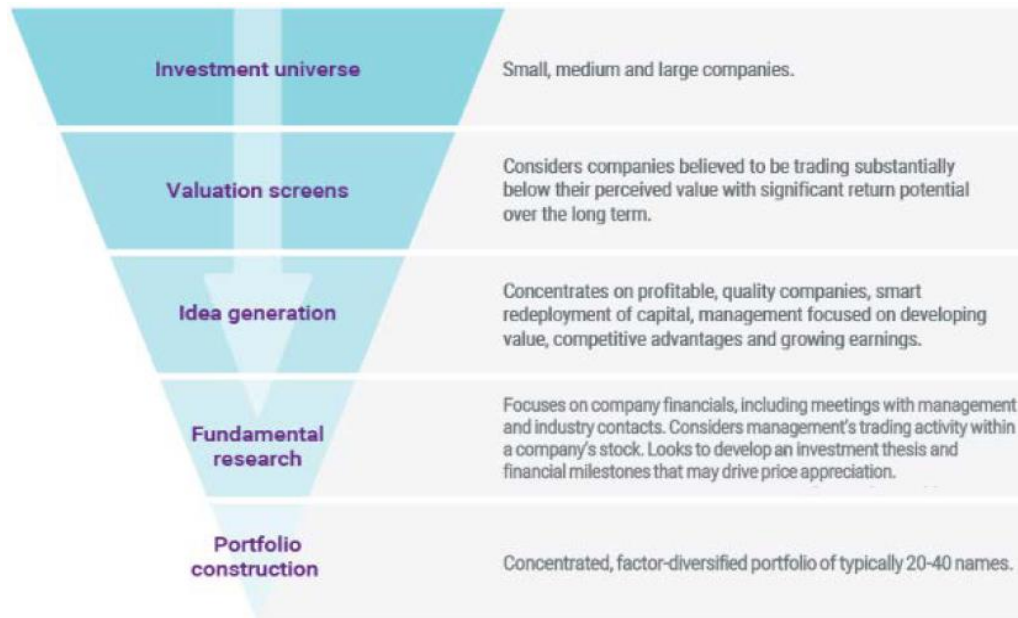

*Risks
